Dear Brothers and Sisters in Christ,

As you will recall, the Bishops of Alberta made a decision to withhold from the *Canadian Catholic Organization for Development and Peace* (CCODP) funds collected this year in our diocesan appeals, including *Share Lent*, *Together We Serve*, and *Together in Action*. This was triggered by indications of non-compliance with Catholic moral teaching on the part of a significant number of CCODP partner agencies.

In response to this determination by many of Canada's Bishops, CCODP reiterated its full adherence, as a Catholic organization, to the Church's social and moral doctrine, especially as regards the sanctity of life from conception to natural death. It undertook further to complete a review of the problematic partnerships and report their findings to the *Canadian Conference of Catholic Bishops* (CCCCB). Preliminary results were delivered to the Bishops during their recent plenary meeting, and CCCC officials are currently assessing them. At the same time, CCODP has promised not to forward any of the funds collected in our 2018 parish collections to problematic partners and has, in addition, imposed a temporary moratorium on any funding of them in the future until all concerns are addressed to the satisfaction of the Bishops.

In a letter dated November 27<sup>th</sup> last, the Executive Director of CCODP informed the Bishops of Alberta of the steps being taken to address the specific issue of the partners identified as problematic. In addition, he advised that they are revising partner selection criteria, adjusting their Partnership Policy and taking measures to improve communications with both the Bishops and all CCODP members. All of this is unfolding in collaboration with officials of the CCCC.

On the basis of the information provided and CCODP's guarantee that the funds collected in 2018 will not be forwarded to partners under review, the Bishops of Alberta have decided to release those same funds to CCODP by the end of this year. We have requested that they give a full accounting to us of the way in which these 2018 funds are eventually distributed.

In addition, because they have placed a temporary funding moratorium on these same partners and have undertaken to review and revise their selection criteria and partnership policy, the Bishops of Alberta will allow the 2019 collection to take place in their Dioceses during the

Lenten season. We continue to expect, of course, that the funds raised in 2019 will be forwarded only to partners whose commitment to Catholic social and moral doctrine is firm. Here, too, we have asked for a full accounting in confirmation of such distribution of the funds.


